WHEREAS the Timaru Borough Council (hereinafter called "the said local authority"), being desirous of raising a loan of ten thousand pounds (£10,000), to be known as "Timaru Streets Improvement Loan, 1944" (hereinafter called "the said loan"), for the purpose of street and footpath sealing and incidental improvements arising therefrom, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council as required by the said Act, should the Governor-General in Council, as required by the said Act, should be given to the raising of the said loan:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the Local Government Loans Board Act, 1926, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of ten thousand pounds (£10,000), and in giving such consent doth hereby determine

- (1) The term for which the said loan or any part thereof may be raised shall be seven (7) years.
- (2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender of lenders a rate exceeding three pounds five shillings (£3 5s.)
- (3) The said loan, or any part thereof, shall be repaid by the annual redemption of debentures on the dates set out in the first column of the Schedule hereunder of the amounts stated opposite each such date in the second column of the said Schedule.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Nelson City Council on the fifteenth day of June, one thousand nine hundred and forty-four,

"That the Nelson City Council, being the local authority having control of the streets in the City of Nelson, by resolution having control of the streets in the City of Nelson, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the north-eastern side of the portion of Tipahi Street adjoining Section 971, City of Nelson, the south-eastern side of the portion of Tipahi Street adjoining Sections 969 and 971, City of Nelson, and the north-western side of the portion of Kawai Street adjoining Sections 969 and 971, City of Nelson, as shown on the plan annexed to this resolution in the Council's minute-book";

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-eastern and south-eastern sides of portions of Tipahi Street and the north-western side of portion of Kawai Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-lines of the said portions of street.
