WHEREAS the lands described in the Schedule hereto were, W by an order of the Native Land Court made on the twenty-fourth day of November, one thousand nine hundred and twenty-five, duly laid out as road-lines in pursuance of section forty-eight

of the Native Land Amendment Act, 1913: And whereas the said Court is of the opinion that it is in the public interest that the said road-lines should be proclaimed as

public roads and a notification to that effect has been forwarded to the Minister of Lands, in terms of section fifty-one of the Native Land Amendment Act, 1913 : And whereas one month's notice in writing of the intention to proclaim the said road-lines as public roads has been given by the Surveyor-General to the local authority of the district concerned, in terms of subsection two of section four hundred and eighty-seven of the Native Land Act 1931 of the Native Land Act, 1931 : And whereas it is now expedient that the said road-lines should

be proclaimed as public roads : Now, therefore, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred by section four hundred and eighty-seven of the Native Land Act, 1931, do hereby proclaim as public roads the road-lines described in the Schedule hereto.
