In pursuance and exercise of the powers conferred by section twelve of the Land Act, 1924, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim as road the land described in the First Schedule hereto; and I do hereby proclaim as closed the road described in the Second Schedule hereto; and I do also hereby take the land described in Third Schedule hereto for the purposes of subsection ten of the said section twelve.
