IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Waimairi County Council on the sixteenth day of February, one thousand nine hundred and forty-four, the portion of street affected by such resolution being more particularly described in the Schedule hereto:—

“That the Waimairi County Council, being the local authority having control of the roads in the County of Waimairi, by resolution declares that the provision of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the side of Sutherland Street adjoining Lot 73, D.P. 121, part R.S. 132, and contained in Certificate of Title, Volume 207, folio 75 (Canterbury Survey District)”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the south-eastern side of the portion of Sutherland Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of road.
