(1) Except as provided in subclause (2) of the last preceding clause and subject to the provisions of subclauses (3), (4), (5), (6), and (7) hereof, the maximum price that may be charged or received by any retailer for any onions to which this Order applies shall be at the rate of a price per pound equal to the sum of the following amounts :—

- (a) The price per pound actually paid or payable by the retailer for the onions:

(3) Notwithstanding anything to the contrary in the foregoing provisions of this clause, but subject to the provisions of subclauses (4) and (5) hereof, the retail price of any onions to which this Order applies shall not in any case exceed a price at the rate of the appropriate price prescribed in the following scale, namely :--
