WHEREAS it has been found desirable for the use, convenience, and enjoyment of the Wellington-Foxton Railway to take further land at Paekakariki in addition to land previously acquired for the purposes of the said railway:

Now, therefore, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, in exercise of the powers

and authorities conferred on me by sections thirty-four and two hundred and sixteen of the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes above mentioned.

APPROXIMATE area of the piece of land: 31.93 perches. Part Lot 1, D.P. 10511, being part Section 40, Wainui District.

Situated in Block II, Paekakariki Survey District, Hutt County. (S.O. 21194.)
