Revoking in Part a Proclamation declaring certain Territories to be Enemy Countries for the Purpose of the Enemy Property Emergency Regulations 1939 and the Enemy Trading Emergency Regulations 1939

IN pursuance and exercise of the powers and authorities vested in me by the Enemy Property Emergency Regulations 1939 and the Enemy Trading Emergency Regulations 1939, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare as follows :--

1. The Proclamation dated the twenty-third day of September, one thousand nine hundred and forty, and published in the *Gazette* on the twenty-sixth day of the same month at page 2391, proclaiming and declaring certain French territories to be enemy countries for the purposes of the Enemy Property Emergency Regulations 1939 and the Enemy Trading Emergency Regulations 1939, is hereby revoked so far as it relates to the territories referred to in the First Schedule hereto.

Schedule hereto. 2. The said Proclamation dated the twenty-third day of September, one thousand nine hundred and forty, is hereby revoked so far as it proclaims and declares the territories described in the Second Schedule hereto to be enemy countries for the purposes of the Enemy Trading Emergency Regulations 1939, but without prejudice to the continuing effect of the said Proclamation so far as it proclaims and declares the territories referred to in the Second Schedule hereto to be enemy countries for the purposes of the Enemy Property Emergency Regulations 1939.
