Revoking Part of a Proclamation defining the Middle-line of a Portion of the Wellington-Napier Railway (Lower Hutt Valley Duplication)

C. L. N. NEWALL, Governor-General [L.S.] A PROCLAMATION

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby revoke so much of the Proclamation dated the tenth day of December, one thousand nine hundred and twenty-four, and published in the New Zealand Gazette No. 81 of the eleventh day of the same month, defining the middle-line of a portion of the Wellington-Napier Railway (Lower Hutt Valley Duplication), in so far as it affects Lot 4, D.P. 10045, part Section 39 (Hutt R.D.), Block IX, Belmont Survey District, being all the land comprised and described in Certificate of Title, Volume 476, folio 263 (Wellington Description) Registry).
