IN pursuance of the powers and authorities vested in me by section two of the Christchurch District Drainage Amendment Act, 1920, and of all other powers and authorities enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby declare that the area described in the Schedule hereto shall be added to and form part of the Christchurch Deriver and District work with the like power and the Christchurch Drainage District; and, with the like powers and authorities, do hereby also declare that the said area shall be added to the Heathcote Subdistrict of the said district.
