Declaring Land acquired for a Government Work, and not required for that Purpose, to be Crown Land

C. L. N. NEWALL, Governor-General [L.S.] A PROCLAMATION

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act, 1924.

In pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken, subject to the right-of-way over part created by Conveyance No. 33391, Deeds Register Office, Dunedin, and to the drainage right and right to overhang eaves in favour of Certificate of Title, Volume 116, folio 232, granted by Memorandum of Transfer No. 28805, Otago Land Registry, for a post-office; and I do also declare that this Proclamation shall take effect on and after the tenth day of October, one thousand nine hundred and forty-five. hundred and forty-five.
