MAURICEVILLE COUNTY COUNCIL

RESOLUTION MAKING SPECIAL RATE

Extract from the minutes of proceedings of the Mauriceville County Council at a meeting of such Council held on the 17th day of September, 1945.

IN pursuance and in exercise of the powers vested in it in that behalf by the Counties Act, 1920, the Local Bodies' Loans Act, 1926, and all other powers (if any) it thereunto enabling, the Mauriceville County Council hereby resolves as follows:—

"That, for the purpose of providing for the payment of interest, principal, and other charges on a loan of eight hundred pounds (£800), authorized to be raised by the Mauriceville County Council pursuant to the provisions of section 25 of the Local Bodies' Loans Act, 1926, for the purposes of renewing the Kopuaranga-Stream Bridge on No. 443 Mauriceville-Hastwell Main Highway, and all other charges incidental thereto, the Mauriceville County Council hereby makes and levies a special rate of one-half of a penny (½d.) in the pound on the rateable value (on the basis of the capital value) of all rateable property in the whole of the County of Mauriceville; and that such special rate shall be an annually recurring rate during the currency of such loan and shall be payable yearly on the 1st day of September in each and every year during the currency of such loan, being a period of twenty (20) years or until the loan is fully paid off."

Moved by Councillor O. Welch, seconded by Councillor A. Forsberg, and carried.

WAIKOHU COUNTY COUNCIL

RESOLUTION MAKING A SPECIAL RATE

IN pursuance and exercise of the powers vested in it in that behalf by section 78 of the Local Bodies' Loans Act, 1926, the Waikohu County Council hereby resolves as follows:—

"That, for the purpose of providing the interest and other charges on the proportion of the public debt of the Otago County transferred to the Waikohu County Council under agreement on transfer of portion of the Otago County to the Waikohu County, the Waikohu County Council hereby makes and levies a special rate of twopence in the pound upon the rateable value of all rateable property of the Otago Special-rating Area, comprising the whole of the area transferred from the Otago County to the Waikohu County by Proclamation on the 1st day of June, 1945, and including Mangatu 1 (part west), D.P. 1551; Block I, Ngateretere Survey District; Part 19, D.P. 1516, of Mangatu I, Block IX, Arowhata; Part 28, D.P. 2384, of Mangatu I, Blocks VI, X, Arowhata Survey District; Part 29, 31, D.P. 2384, of Mangatu I, Blocks V, VI, IX, Arowhata Survey District; Lot 30, D.P. 2384, of Mangatu I, Block V, Arowhata Survey District; Lot 32, D.P. 2384, of Mangatu I, Block V, Arowhata Survey District; Lots 1 to 18 of Motu Extension No. 1; Lots 1 to 42, D.P. 2349, of Motu Township Extension 3; Lots Part 22, 1 of 15, 2 of 15, 3 of 15, Part 15, Part 16, 1 of 17, and Part 27; 2 of 17 and Part 27, 18, 19, 20, 21, 1 of 23, and Part 23, part Section 23, Lot 2 of 24, 25, 28, 29, 30, 31, 32, Block II, Motu Survey District; Section 22 of Block II and 1 of Block III, 34 to 36, 38, 39 of Block II, Motu Survey District; Section 40, Block II, Motu Survey District, and Part 1 and 11, Block IV, Urutawa East Survey District; 41, 37, Block II, Motu Survey District; Section 1, Block V, Otipi Survey District; Section 2 of VI, Otipi Survey District; Sections 3, 5, Block VIII, Urutawa Survey District; Section 3 of Block I, 5/6, Block III, Urutawa East Survey District; Sections 1, 2, Block II, Urutawa East Survey District; Section 2, Block III, Urutawa East Survey District; Section 3, Block III, Urutawa East Survey District, and Section 24, Block II, Motu Survey District; Part 1, Part 2 of Section 2, Block IV, Urutawa East Survey District; Section 4, Block III, Urutawa East Survey District; Lot 1, Section 2, Block IV, Urutawa East Survey District; 1 of Section 2, Block IV, Urutawa East Survey District; Sections 3, 4, 5, 6, 7, 10, 8, 9 of Block IV, Urutawa East Survey District; Whakapaupakihi 1, Part 2, Part 2, 46, Block II, Motu Survey District; Lot 10, Whakapaupakihi 3; Lots 1, 9, 11, 12, Block II, Motu Survey District; part Whakapaupakihi 3; Whakapaupakihi Part 4 and closed road; Whakapaupakihi Part 4 and closed road; Railway Reserve, Motu-hora; Section 12, Block IV, Urutawa East Survey District; Section 7, Block III, Urutawa East Survey District; and that such special rate shall be an annually recurring rate during the currency of such portion of the said public debt and be payable yearly on the 1st day of July in each and every year during the currency of such debt, being a period of seventeen years or until such debt is fully paid off."
