IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril power and authority in anywise enabling me in this behalt, I, Cyrll Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for a maternity home and shall vest in the Wanganui Hospital Board as from the date hereinafter mentioned; and I do also declare that this Proclamation shall take effect on and after the thirty-first day of October, one thousand nine hundred and forty-five.

W HEREAS by section thirty of the Rabbit Nuisance Act, 1928, it is enacted that the Governor-General may, by Order in Council, on petition in that behalf signed by a majority of the persons qualified to be enrolled on the ratepayers' list for any proposed district, constitute and declare any area of land of not less than one thousand acres a rabbit district under and for the purposes of Part II of the said Act.

And whereas, in pursuance of the provisions of the said section thirty of the said Act, a petition has been received praying that the area of land described in the Schedule hereto be constituted and declared a rabbit district under and for the purposes of Part II of the said Act. of the said Act:

And whereas the said petition is signed by a majority of the persons in the said area of land qualified to be enrolled on the ratepayers' list for the said proposed district, and it is deemed

ratepayers' list for the said proposed district, and it is deemed expedient to give effect to the prayer of the petitioners accordingly:

Now, therefore, in pursuance and exercise of the powers and authorities conferred upon him by the said Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby constitute by the specific name of the "Northern Hawke's Bay Rabbit District" and declare that area of land defined in the Schedule hereto to be a rabbit district under and for the purpose of Part II of the said Act; and doth hereby further declare that the basis on which the Board to be established for the said district shall first levy its general rate shall be on the basis of the acreage of the rateable property in the said district. district.
