New Zealand Emergency Standard Specification amended

NOTICE is given of the issue of Amendment No. 2 (dated December, 1945) to the New Zealand Emergency Standard Specification entitled "Grades of Meat for Sale on the Local Market and Definitions of Joints and Cuts" bearing date July, 1943, and numbered N.Z.S.S. E. 79, which is cited in the Board of Trade (Meat Grading) Regulations 1943.* The said amendment shall come into force upon the expiry of seven days following the date of publication of this notice in the *Gazette*.
