Authorizing the Acquisition of Native Land notwithstanding the Provisions as to Limitation of Area

ORDER IN COUNCIL

At the Government Buildings at Wellington, this 27th day of December, 1945

Present:

THE HON. W. NASH PRESIDING IN COUNCIL

PURSUANT to section two hundred and forty-six of the Native Land Act, 1931, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council, doth hereby authorize the alienation by way of transfer to and the acquisition by Konga Wharetuani, of Chatham Islands, Farmer, of the land mentioned in the Schedule hereto, notwithstanding the provisions of Part XII of the Native Land Act, 1931.

SCHEDULE

ALL that area of land situate in the Chatham Islands, being the Native Land Court subdivision known as Wharekauri No. 1N or Tioriori Block, comprising an area of 5,185 acres 1 rood, and being the whole of the land comprised in Certificate of Title, Volume 406, folio 154 (Wellington Registry).
