6. Duration of License

Unless sooner determined, this license shall continue in force until the 31st day of March, 1966, or until electrical energy is available from an Electric-power Board or other general public source, whichever is the earlier.

7. RENTAL

For the purpose of assessing the annual rental payable in respect of this license, the licensee may install a suitable maximum-demand indicator to the satisfaction of the Inspecting Engineer of the Public Works Department, and failing such installation the rental shall be assessed on the maximum generating capacity of the plant installed. The present plant is rated at 7.5 kilowatts.
