RESOLUTION MAKING AND LEVYING SPECIAL RATE

NOTICE is hereby given that the following resolution was passed at a meeting of the Hutt Valley Electric-power Board held on the 13th day of December, 1945:—

"In pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Hutt Valley Electric-power Board hereby resolves as follows:-

"That, for the purpose of providing the interest and other charges on a loan of £100,000, authorized to be raised by the Hutt Valley Electric-power Board under the above-mentioned Act to provide additional moneys for the further reticulation of the Hutt Valley Electric-power Board's district, the said Hutt Valley Electric-power Board hereby makes and levies a special rate of thirty-five one-hundredths (35/100ths) of a penny in the pound on the rateable value (on the basis of the unimproved value) of all rateable property of the Hutt Valley Electric-power District; and that such special rate shall be an annual-recurring rate during the currency of such loan and be payable yearly on the 1st day of March in each and every year during the currency of such loan, being a period of twenty-five (25) years or until the loan is fully paid off."
