A PROCLAMATION

PURSUANT to the Public Works Act, 1928, I, Sir Michael Myers, the Administrator of the Government of the Dominion of New Zealand, do hereby proclaim and declare that the additional land described in the Schedule hereto is hereby taken for a recreation-ground and shall vest in the Mayor, Councillors, and Burgesses of the Borough of New Lynn as from the date hereinafter mentioned; and I do also declare that this Proclamation shall take effect on and after the thirteenth day of May, one thousand nine hundred and forty-six.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Sir Michael Myers, the Administrator of the Government of the Dominion of New Zealand, do hereby revoke the Proclamation dated the twenty-third day of February, one thousand nine hundred and forty-four, and published in the *New Zealand Gazette* No. 16 of the second day of March, one thousand nine hundred and forty-four, at page 209, and deposited in the Land Registry Office at Auckland as No. 11408, taking land for a public school in Block VI, Coromandel Survey District, such land being no longer required.
