A PROCLAMATION

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the Crown land described in the Schedule hereto is hereby set apart for a Public Works yard and depot; and I do also hereby declare that this Proclamation shall take effect on and after the eleventh day of February, one thousand nine hundred and forty-six.

SCHEDULE

APPROXIMATE area of the piece of Crown land set apart: 2 acres. Being Sections 1, 2, 3, 4, 8, 9, 10, and 11, Block VIII, Town of Ohakune.

Situated in Block VIII, Makotuku Survey District (Borough of Ohakune). (S.O. 15614.)

Boundaries of Christchurch Drainage District altered

A PROCLAMATION

IN pursuance and exercise of the powers and authorities vested in me by section two of the Christchurch District Drainage Amendment Act, 1920, as extended by the Christchurch District Drainage Amendment Act, 1944, and of all other powers and authorities enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that as on and from the first day of April, one thousand nine hundred and forty-six, the area described in the Schedule hereto shall be added to and form part of the Christchurch Drainage District; and, with the like powers and authorities, do hereby also proclaim and declare that the said area shall be added to the Rural Heathcote Sub-district of the said district.

SCHEDULE

ALL that area in the County of Heathcote, Canterbury Land District, bounded by a line commencing at a point on the northern side of Roscoe Street in line with the eastern boundary of Lot 13 on plan deposited in the Canterbury District Land Registry Office at Christchurch as No. 8624, being a point on the boundary of the City of Christchurch (*New Zealand Gazette*, 1944, pages 1254 and 1508); thence in a southerly direction by a right line to and along the eastern boundary of the said Lot 13, and the eastern boundary of Lot 9 on plan deposited as aforesaid as No. 8624 to Leonard Street; thence easterly along the northern side of that street and its production to a point on the boundary of the City of Christchurch; thence north-westerly and easterly along that boundary to the point of commencement.
