Revolving a Proclamation taking Additional Land at Greatford for the Purposes of the Foxton - New Plymouth Railway

#### A PROCLAMATION

In pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the sixteenth day of April, one thousand nine hundred and forty-six, and published in the New Zealand Gazette No. 26 of the twenty-fourth day of April, one thousand nine hundred and forty-six, page 517, taking additional land at Greatford for the purposes of the Foxton – New Plymouth Railway.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand, and issued under the Seal of that Dominion, this 26th day of September, 1946.

### A PROCLAMATION

PURSUANT to the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the Crown land described in the Schedule hereto is hereby set apart for a main highway depot; and I do also declare that this Proclamation shall take effect on and after the fourteenth day of October, one thousand nine hundred and forty-six.

#### SCHEDULE

APPROXIMATE area of the piece of Crown land set apart: 2 acres 3 roods 4 perches. Being part Section 20.

Situated in Block XI, Puhipuhi Survey District (Marlborough R.D.). (S.O. 3823.)

PURSUANT to section thirty-five of the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act, 1924.

32 perches.

Being Lot 649, D.P. 18380, being part Allotment 19, District of Tamaki.

Situated in Block IX, Rangitoto Survey District (City of Auckland) (Auckland R.D.). (S.O. 34101.)
