## Special Order

THE Auckland Metropolitan Drainage Board doth hereby in exercise of the powers vested in it in that behalf by the Auckland Metropolitan Drainage Act, 1944, the Local Bodies' Loans Act, 1926, the Local Government Loans Board Act, 1926, and their respective amendments, and of all other powers enabling it in that behalf, resolve, by special resolution intended to operate as a special order, to borrow the sum of twenty-five thousand five hundred pounds (£25,500) as a special loan, to be designated "Loan No. 3, 1946, £25,500," for the following purposes:—

- Constructing Branch Sewer No. 9, sixth portion, in the Oakley Creek watershed, exclusive of amount of subsidy payable by the Department of Housing Construction estimated at £3,900 .. .. . £15,500
- Constructing six pumping-stations and laying rising mains in the Remuera, Grey Lynn, and Point Chevalier districts of Auckland City .. .. . £10,000

PURSUANT to the powers vested in it by the Christchurch District Drainage Amendment Act, 1922, the Christchurch Drainage Board hereby resolves that the boundary of the said Special Area hereinbefore described and defined shall be further altered so as to include in the said Special Area all those areas more particularly described in the Schedules hereto; and further resolves that the said areas shall form part of and be included in the Sub-division B of the said Special Area and that the boundaries of the said Sub-division B shall be altered accordingly so as to include all those areas more particularly described in the Schedules hereto.
