AREA PROPOSED TO BE EXCLUDED FROM THE COUNTY OF WAIMAIRI AND INCLUDED IN THE CITY OF CHRISTCHURCH

ALL that area in the County of Waimairi, Canterbury Land District, situated in Block XII, Christchurch Survey District, and bounded by a line commencing at a point on the right bank of the River Avon in line with the western side of Gayhurst Road, proceeding generally northerly across the River Avon and Dallington Terrace, to and along the western side of Gayhurst Road to McBratney's Road; thence westerly along the southern side of that road to Dallington Terrace, and the production of the last-mentioned line to a point on the boundary of the City of Christchurch; thence generally in a southerly direction along that boundary to the point of commencement.

AREA PROPOSED TO BE CONSTITUTED AS THE BOROUGH OF PUTARURU
