ORDER

1. This Order may be cited as the New Zealand National Airways Corporation Extension of Powers Order 1947. 2. Approval is hereby given to the New Zealand National Airways Corporation, with a view to facilitating the establishment, Antways Corporation, with a view to factuating the establishment, maintenance, and operation of air services between New Zealand and Fiji, and places beyond Fiji, entering into and carrying out agreements with any organizations concerned with the operation of air services whereby the Corporation agrees to provide and operate in Fiji facilities for the maintenance of aircraft belonging to these comparison to those organizations.
