A PROCLAMATION

PURSUANT to the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the fifteenth day of March, one thousand nine hundred and forty-seven, and published in the *New Zealand Gazette* No. 15 of the twentieth day of the same month, at page 326, taking land in Block XI, Paekakariki Survey District, for better utilization, in so far as it affects the land described in the First and Second Schedules hereto, such land being no longer required.
