(2) In lieu of a rate of interest not exceeding three pounds ten shillings (\pounds 3 10s.) per centum per annum, as specified in clause two of the said Order in Council, the rate of interest that may be paid in respect of the said sum or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding three pounds five shillings (\pounds 3 5s.) per centum per annum.

(3) In lieu of repayment by annual instalments of principal of not less than two hundred and fifty pounds (£250) each, as specified in clause three of the said Order in Council, the said sum by equal aggregate annual or half-yearly instalments extending over the term as determined in (1) above.
