

the northern and western boundaries of Section 11 aforesaid, the western boundaries of Section 10, the western boundaries of part Section 1, and the northern boundaries of Section 21, all of Block VI aforesaid; thence north-westerly generally along a right line, across a public road, the north-eastern boundaries of Section 1, the eastern and northern boundaries of part Section 8, and Lot 1 of Section 8, all of Block V, Tangitu Survey District, a right line across a public road, and along the southern boundary of Section 9, Block IV, Aria Survey District, to the easternmost corner of Section 6, Block IV aforesaid; thence along the south-eastern boundary of Section 6 and the eastern boundary of Section 8, Block IV aforesaid, to the south-eastern corner of the last-mentioned section; thence westerly along the southern boundaries of Sections 8 and 7, Block IV aforesaid, to the eastern boundary of Section 1, Block VIII, Aria District; thence northerly along that boundary to the northernmost point of the said Section 1; thence along the northern boundaries of Blocks VIII and VII, and the eastern and southern boundaries of Block VI, Aria Survey District, to the Puketawai Trig. Station; thence along the southern and western boundaries of Section 9 and the southern boundaries of Section 6, Block VI aforesaid, to the Waitewhena Road; thence along the Waitewhena Road to the southern boundary of Section 8, Block V, Aria Survey District; thence along the southern and western boundaries of Section 8 and the southern boundaries of Sections 3 and 2, Block V aforesaid, to the south-western corner of the last-mentioned section; thence along the eastern and southern boundaries of Section 11, Block V aforesaid, to the western boundary of the Aria Survey District; thence southerly along the western boundary of the Aria Survey District aforesaid to its intersection with the Panirau Stream; thence down the middle of the Panirau Stream to the middle of the Mokau River; thence up the middle of the Mokau River to its confluence with the Mangaotaki River, in Block III, Awakino East Survey District, the point of commencement.

*Mangapehi-Tiroa Tribal Committee Area*

All that area bounded by a line commencing at the junction of the Kurakura and Mapiu Roads, in Block VII, Mapara Survey District; thence south-easterly generally along the western side of the Mapiu Road to the easternmost corner of Section 23, Block XI, Mapara Survey District; thence north-easterly generally along a right line, across the Mapiu Road and Stream, to the westernmost corner of Section 19, Block XII, Mapara Survey District; thence along the western, northern, and eastern boundaries of the said Section 19 to its easternmost corner; thence along a right line to the Mangarahiri Trig. Station, in Block XIII, Mapara Survey District; thence north-easterly along a right line, passing through Pukeroa Trig. Station, in Block XIV, Ranginui Survey District, to its intersection with a right line drawn from Rangitoto Trig. Station, in Block IV, Pakaumanu Survey District, to the source of the Ongarue River, the said intersection being a point on the south-western boundary of the Otorohanga Tribal Committee Area hereinbefore described; thence north-westerly along that boundary to the easternmost corner of the Te Kuiti Tribal Committee Area hereinbefore described; thence westerly generally along the southern boundaries of that district, to and along the south-eastern boundaries of the Piopio Tribal Committee Area hereinbefore described to the junction of the Kurakura and Mapiu Roads, being the point of commencement.

*Waimiha Tribal Committee Area*

All that area bounded by a line commencing at the junction of the Waitataura and Mapiu Roads, in Block II, Tangitu Survey District, being a point on the eastern boundary of the Aria Tribal Committee Area hereinbefore described; thence northerly along that boundary to the easternmost corner of Section 23, Block XI, Mapara Survey District, being a point on the southern boundary of the Mangapehi-Tiroa Tribal Committee Area hereinbefore described; thence north-easterly along that boundary to the intersection of the production of a right line drawn from Trig. Station Mangarahiri through Pukeroa Trig. Station, and a right line drawn from Rangitoto Trig. Station to the source of the Ongarue River; thence south-easterly along that line to the source of the Ongarue River; thence westerly along a right line to Trig. Station 1394 (Pukemako), in Block V, Hurakia Survey District; thence south-westerly along a right line to Trig. Station Z (Kopuha), in Block XIII, Ongarue Survey District; thence north-westerly along a right line to the junction of the Waitataura and Mapiu Roads, being the point of commencement.

PUTAUKI TRIBAL DISTRICT

*Pahipoto Tribal Committee Area*

All that area bounded by a line commencing at the intersection of a right line from Mount Edgecumbe Trig. Station, in Block XIII, Rangitaiki Upper Survey District, to the westernmost corner of Allotment 110, Rangitaiki Parish, in Block VI, Awa o te Atua Survey District, with the northern boundary of Section 148, Matata Parish, in Block VI, Rangitaiki Upper Survey District, and proceeding northerly along this right line and its production to the sea-coast; thence easterly along the sea-coast and a right line to the middle of the Rangitaiki River; thence southerly generally up the middle of that river to the production of the southern boundary of Part 1c of Allotment 72B, Matata Parish, in Blocks VI and VII, Rangitaiki Upper Survey District; thence westerly to and along that boundary and the southern boundaries of 1A, 1B 2, 1B 1, another Part 1c and 1d, all of Allotment 72B aforesaid, including the crossing of two roads; thence along a right line to the intersection of the right line from Mount Edgecumbe Trig. Station to the westernmost corner of Allotment 110, Rangitaiki Parish, with the northern boundary of Section 148 aforesaid, the point of commencement.

*Hekerangi Tribal Committee Area*

All that area bounded by a line commencing at Mount Edgecumbe Trig. Station, in Block XIII, Rangitaiki Upper Survey District, and proceeding northerly along a right line to the south-western corner of the Pahipoto Tribal Committee Area hereinbefore described; thence easterly along the southern boundary of that area to the middle of the Rangitaiki River; thence southerly generally up the middle of that river to its intersection with a right line from Mount Edgecumbe Trig. Station to the north-eastern corner of Allotment 60H, Rangitaiki Parish; thence westerly along this right line to Mount Edgecumbe Trig. Station, the point of commencement.

*Omataroa Tribal Committee Area*

All that area bounded by a line commencing at Te Tiringa Trig. Station, in Block VIII, Rangitaiki Upper Survey District, and proceeding along right lines to Omataroa Trig. Station, in Block XV, Rangitaiki Upper Survey District, and to the north-eastern corner of Allotment 60H, Rangitaiki Parish; thence westerly to the south-eastern corner of the Hekerangi Tribal Committee Area hereinbefore described; thence northerly along the eastern boundaries of the Hekerangi and Pahipoto Tribal Committee Areas hereinbefore described to the sea-coast; thence easterly along the sea-coast to the northerly production of a right line through Owataiti Trig. Station, in Block 1A, Whakatane Survey District, to Te Tiringa Trig. Station aforesaid; thence southerly along this line to Te Tiringa Trig. Station, the point of commencement.

*Taiwhakaea Tribal Committee Area*

All that area bounded by a line commencing at Owataiti Trig. Station, in Block 1A, Whakatane Survey District, and proceeding northerly along the production of a right line from Te Tiringa Trig. Station, in Block VIII, Rangitaiki Upper Survey District, to the sea-coast; thence easterly along the sea-coast to the production of the south-eastern boundary of Subdivision 2B 1 of Allotment 28B, Rangitaiki Parish; thence south-westerly to and along that boundary to the southern corner of the said Subdivision 2B 1; thence southerly along a right line to the north-western corner of Subdivision 9B of Allotment 28B aforesaid, and along the western boundaries of Subdivisions 9B and 3c 3 to the westernmost corner of Subdivision 3c 3, and along a right line to the westernmost corner of Subdivision 5A of Allotment 28B, being a point on the northern side of a road; thence westerly along the northern side of this road and the Tauranga-Whakatane Road to its intersection with the right line from Te Tiringa Trig. Station to Owataiti Trig. Station; thence northerly along this right line to Owataiti Trig. Station, the point of commencement.

*Patuwai Tribal Committee Area*

All that area bounded by a line commencing at the south-western corner of the Taiwhakaea Tribal Committee Area hereinbefore described, and proceeding easterly along the southern boundary of that area to its south-eastern corner; thence southerly along a right line to the north-western corner of Subdivision F 3 of Allotment 29, Rangitaiki Parish, and along the western boundary of that subdivision and its production across the Whakatane River to the boundary of the Borough of Whakatane, as described in *New Zealand Gazette* of 1940, at page 2781; thence westerly and southerly along that boundary to the production of the south-eastern side of Te Kahu Drain Reserve; thence south-westerly to and along the south-eastern side of that reserve to its intersection with the southern side of the road forming the northern boundary of Subdivision 1 of Allotment 30B, Rangitaiki Parish, in Block I, Whakatane Survey District; thence westerly along the southern side of this road and the road through Allotments 73 and 74, Rangitaiki Parish, to its intersection with the right line from Te Tiringa Trig. Station to Owataiti Trig. Station; thence northerly along that right line to the south-western corner of Taiwhakaea Tribal Committee Area, the point of commencement.

*Pukeko Tribal Committee Area*

All that area bounded by a line commencing at the south-western corner of Patuwai Tribal Committee Area hereinbefore described, and proceeding easterly and north-easterly along the southern boundary of that area to the boundary of the Borough of Whakatane, as described in *New Zealand Gazette* of 1940, at page 2781; thence easterly and southerly along that boundary to the southern side of Bridge Street, being a point on the right bank of the Whakatane River; thence south-westerly along that bank to a point due east of the confluence of the Waioho Stream with the Whakatane River; thence to and up the middle of that stream in a southerly direction generally to its intersection with the production of the southern boundary of Allotment 30A 1, Rangitaiki Parish; thence westerly to and along that boundary and the southern boundary of Allotment 30c, Rangitaiki Parish, and its production to the intersection with a right line between Te Tiringa and Owataiti Trig. Stations hereinbefore referred to; thence northerly along that right line to the south-western corner of Patuwai Tribal Committee Area, the point of commencement.

*Rangataua Tribal Committee Area*

All that area bounded by a line commencing at the south-western corner of Pukeko Tribal Committee Area hereinbefore described, and proceeding easterly and northerly along the southern and eastern boundaries of that area to the confluence of the Waioho Stream with the Whakatane River; thence southerly up the middle of that river to its intersection with a right line between the
