

Block, and along the south-western and eastern boundaries of Waimana No. 1D Block and the eastern boundary of Waimana No. 1c Block to the north-eastern corner of Section 21, Block IV, Waimana Survey District; thence along the north-eastern boundary of the aforesaid Section 21, the southern boundaries of Allotments 273, 269, and 268, Waimana Parish, across the Whakatane-Opotiki Main Highway to the south-eastern corner of Allotment 223, Waimana Parish; thence in a northerly direction generally along the western side of the Whakatane-Opotiki Main Highway to its junction with the generally western side of the Wainui Road, in Block XI, Whakatane Survey District; thence along the western side of the Wainui Road to a point due west of the southernmost corner of Lot 4 on the Land Transfer Plan numbered 14254, lodged in the office of the District Land Registrar at Auckland; thence north-easterly along a right line to a point in the middle of the mouth of the Nukuhou River and a right line to the middle of the entrance of the Ohiwa Harbour, the point of commencement.

EASTERN TUHOE TRIBAL DISTRICT

Rarua Tribal Committee Area

All that area bounded by a line commencing at the north-eastern corner of Ruatoki D Section 1, in Block II, Waimana Survey District, and proceeding easterly along the southern boundaries of Section 7, Block II, Waimana Survey District, of Lots 5, 7, and Part 8 on the plan numbered 8930, lodged in the office of the District Land Registrar at Auckland, to the intersection of the last-mentioned southern boundary with the eastern boundary of Section 18, Block III, Waimana Survey District; thence southerly generally along the eastern boundary of the said Section 18, across a road, and along the eastern boundaries of Sections 13, 7, and 6, Block III aforesaid, and the eastern and southern boundaries of Section 5, Block III aforesaid, to the north-eastern corner of Waimana 1c 2 Block; thence along the eastern and southern boundaries of that block to the westernmost corner of Waimana 1D 1B Block; thence south-easterly along the south-western boundaries of Waimana 1D 1B, 1D 4c, and 1D 5 Blocks to the intersection of the boundary of the last-mentioned block with the middle of the Waimana River; thence up the middle of the Waimana River to its intersection with the south-western boundary of Tahora 2AD 2 Block; thence north-westerly along a right line to the north-eastern corner of Whanganui Block; thence along the northern and western boundaries generally of that block and the production of the last-mentioned boundary to the middle of the Waimana River; thence up the middle of the Waimana River to a point in line with the north-western boundary of Oponua Block; thence along a right line due west to the watershed between the Whakatane and Waimana Rivers; thence northerly along that watershed to the south-eastern corner of the Tuturitanga Block, and along the eastern boundaries of that block and of Te Pohue No. 2 Block to the north-eastern corner of the last-mentioned block; thence due north along a right line to the middle of the road forming part of the southern boundary of Ruatoki D Section 6; thence north-easterly along the middle of that road to a point in line with the eastern boundary of the said Section 6; thence northerly to and along that boundary and the eastern boundaries of Ruatoki D Sections Part 4, 5, Part 4, 3, 2, and 1 to the north-eastern corner of the last-mentioned section, the point of commencement.

Tuapo Tribal Committee Area

All that area bounded by a line commencing at a point in the middle of the Waimana River in line with the north-western boundary of Oponua Block; thence up the middle of the Waimana River to a point in line with the south-eastern corner of Tuapou Block; thence to and along the southern boundary of that block to its south-western corner; thence due westerly along a right line to the watershed between the Whakatane and Waimana Rivers; thence northerly along that watershed to a point due west of the intersection of the production of the north-western boundary of Oponua with the middle of the Waimana River; thence due easterly along a right line to the said intersection, being the point of commencement.

Matahi Tribal Committee Area

All that area bounded by a line commencing at a point in the middle of the Waimana River in line with the southern boundary of Tuapou Block; thence up the middle of the Waimana River to its confluence with a stream forming the southern boundary of Hukanui Block; thence south-westerly generally up the middle of that stream to its source; thence due west to the watershed between the Whakatane and Waimana Rivers; thence northerly along that watershed to a point due west of the south-western corner of Tuapou Block, being a point on the southern boundary of the Tuapo Tribal Committee Area hereinbefore described; thence easterly along that boundary to the middle of the Waimana River, the point of commencement.

Whakarae Tribal Committee Area

All that area bounded by a line commencing at the confluence of the Waimana River and a stream forming the southern boundary of the Hukanui Block; thence north-easterly along a right line to the southernmost corner of Tamataohine Block, being a point on the south-western boundary of Tahora 2AD 2 Block; thence south-easterly along the western boundary of Tahora Block to its intersection with the southern boundary of the Waioeka South Survey District; thence westerly along that boundary and the southern boundary of the Urewera Survey District to the watershed between the Whakatane and Waimana Rivers; thence northerly along that watershed to a point due west of the source of the stream forming the southern boundary of the Hukanui Block; thence to and down the middle of that stream to its confluence with the Waimana River, the point of commencement.

Tauanui Tribal Committee Area

All that area bounded by a line commencing at the north-eastern corner of Section 18, Block III, Waimana Survey District, and proceeding easterly along the southern boundaries of Lots 8, 9, 10, and 11 on the plan numbered 8930, lodged in the office of the District Land Registrar at Auckland, and of Allotments 220, 221, and 223, Waimana Parish, to the north-eastern corner of Section 19, Block IV, Waimana Survey District; thence southerly generally along the eastern and south-eastern boundaries of the said Section 19, and the production of the last-mentioned boundary to the middle of the Waimana River; thence up the middle of that river to a point in line with the northern boundary of Waimana 1c 1A 3A 1 Block; thence to and along that boundary to the north-western corner of the said block, being a point on the eastern boundary of Rarua Tribal Committee Area hereinbefore described; thence northerly along that boundary to the north-eastern corner of Section 18, Block III, Waimana Survey District, the point of commencement.

Te Pouahinau Tribal Committee Area

All that area bounded by a line commencing at a point in the middle of the Waimana River in line with the northern boundary of Waimana 1c 1A 3A 1 Block, being also a point on the southern boundary of the Tauanui Tribal Committee Area hereinbefore described; thence westerly along the boundary of that area and southerly generally along the eastern boundary of the Rarua Tribal Committee Area hereinbefore described to the middle of the Waimana River; thence down the middle of that river to a point in line with the northern boundary of Waimana 1c 1A 3A 1 Block, the point of commencement.

Tanatana Tribal Committee Area

All that area bounded by a line commencing at the south-eastern corner of Waimana 1c 1c 3 Block; thence south-westerly along the south-eastern boundaries of Waimana 1c and 1D Blocks; thence north-westerly along the south-western boundary of Waimana 1D Block to the middle of the Waimana River; thence down the middle of that river to the southern boundary of Waimana 1c 1c 3 Block; thence easterly along that boundary to the south-eastern corner of the said block, being the point of commencement.

Tataiahape Tribal Committee Area

All that area bounded by a line commencing at the easternmost corner of Section 21, Block IV, Waimana Survey District; thence south-westerly along the south-eastern boundaries of the said Section 21 and of Waimana 1c Block to the south-eastern corner of Waimana 1c 1c 3 Block; thence along the southern boundary of that block and its production to the middle of the Waimana River; thence down the middle of that river to a point in line with the south-eastern boundary of Section 19, Block IV, Waimana Survey District; thence to and along that boundary and the eastern boundary of the said Section 19 to its north-eastern corner; thence easterly generally along the northern boundary of Waimana 1E Block and the northern and north-eastern boundaries of Section 21 to its easternmost corner, the point of commencement.

Omuriwaka Tribal Committee Area

All that area bounded by a line commencing at the intersection of the south-western boundary of Tahora 2AD 2 Block with the middle of the Waimana River; thence south-easterly along the boundary of the Tahora 2AD 2 Block to the southernmost corner of Taumataohine Block; thence south-westerly along a right line to the confluence of the Waimana River and the stream forming the southern boundaries of the Hukanui Block; thence down the middle of that river to a point in line with the south-western boundary of Whanganui Block; thence to and along that boundary and the western and northern boundaries of Whanganui Block to its north-eastern corner; thence along a right line to the intersection of the south-western boundary of Tahora 2AD 2 Block with the middle of the Waimana River, the point of commencement.

SOUTHERN TUHOE TRIBAL DISTRICT

Patuheuheu Tribal Committee Area

All that area bounded by a line commencing at Mount Edgecumbe Trig. Station, in Block XIII, Rangitaiki Upper Survey District, and proceeding easterly along right lines to the north-eastern corner of Allotment 60H, Rangitaiki Parish, in Block XV, Rangitaiki Upper Survey District, and to the north-eastern corner of Allotment 60D, Rangitaiki Parish; thence southerly along the eastern boundaries of Allotments 60D and 60C, Rangitaiki Parish, to the south-eastern corner of the said Allotment 60C; thence westerly along the southern boundary of that allotment to Tapapakiakia Trig. Station; thence south-westerly and south-easterly along right lines to Te Hiwera and Taumatamiri Trig. Stations, in Block IV, Rangitaiki Lower Survey District; thence south-easterly along a right line in the direction of Kaipurapuna Trig. Station to its intersection with the eastern boundary of Block VIII, Rangitaiki Lower Survey District; thence southerly along the eastern boundaries of Blocks VIII, XII, and XVI, Rangitaiki Lower Survey District, and of Blocks IV and VIII, Galatea Survey District, to the south-eastern corner of the said Block VIII; thence south-westerly along a right line to Tawhiuau Trig. Station, in Block XIV, Galatea Survey District; thence north-westerly along a right line to Trig. Station H, in Block V, Galatea Survey District; thence northerly along a right line to Mount Edgecumbe Trig. Station, the point of commencement.
