*Nihoniho-Ohura Tribal Committee Area*

All that area bounded by a line commencing at the confluence of the Wanganui River and the Ohura River; thence up the middle of the Ohura River till it is intersected by the 39th parallel of south latitude; thence along the said 39th parallel to the western boundary of Block IV, Pouatu Survey District; thence along that boundary and the western boundary of Block XVI, Waro Survey District, to the confiscation boundary-line; thence along that line to the Tangarakau Stream; thence along that stream and along the Waitaanga Stream to the Kotare Road at the southern boundary of Section 2, Block VII, Waro Survey District; thence along the Kotare Road and the southern boundaries of Sections 1 and 3, Block VI, Waro Survey District, to the south-western corner of the last-mentioned section; thence along the western boundaries of Sections 3, 4, 5, and 6, Block VI aforesaid, to the north-western corner of the said Section 6; thence along the northern boundary of the said Section 6 to the Mohakatino Road at its north-eastern corner; thence along the said road to a stream intersecting the Mohakatino-Parinihi No. 1D Block; thence down that stream to its confluence with the Mohakatino Stream near the westernmost corner of Section 1, Block III, Waro Survey District; thence up the Mohakatino Stream and along the northern boundary of Section 3, Block III aforesaid, to Trig. Station (Tawhitirapeka); thence along the western boundary of the Mokau-Mohakatino No. 1R Block and the production thereof to the middle of the Mokau River; thence up the middle of that river to its confluence with the Panirau Stream; thence up the middle of that stream to the western boundary of Aria Survey District; thence northerly along that boundary to the south-western corner of Section 11, Block V, Aria Survey District; thence along the southern and eastern boundaries of the said Section 11 to the south-western corner of Section 2, Block V, Aria Survey District; thence along the southern boundary of the said Section 2 and the southern boundary of Section 3 of the aforesaid block to its easternmost corner; thence along the western and southern boundaries of Section 8, Block V, Aria Survey District, to the Waitewhena Road; thence across and along that road to the south-western corner of Section 6, Block VI, Aria Survey District; thence along the southern boundary of Section 6, the western, southern, and eastern boundaries of Section 9, and the generally eastern boundaries of Sections 16 and 10, all of Block VI, Aria Survey District; thence along the south-western, southern, and eastern boundaries of Section 7, Block III, Aria Survey District, to the Mokau-Ohura Road; thence across that road and along the southern boundary of Section 10, Block III, Aria Survey District, to the western boundary of Section 12 of the aforesaid block; thence along the western, southern, and eastern boundaries of the said Section 12, and the south-eastern boundary of the aforesaid Section 10 to the western boundary of Rangitoto-Tuhua No. 61D Section 2B Block; thence southerly along the western boundary of the aforesaid block, and along the western boundary of Section 7, Block IV, Aria Survey District, to the southern boundary of the aforesaid block; thence along the generally southern boundary of the said Block IV, the generally southern boundary of Block I, Tangitu Survey District, to the southernmost corner of Section 35, Block I, Tangitu Survey District; thence along the production of the south-western boundary of the said Section 35 to the middle of the Hiwi Road; thence along the middle of the said road to a point in line with the south-western boundary of Section 2, Block II, Tangitu Survey District, being a point on the boundary of the Ongarue Tribal Committee Area hereinbefore described; thence southerly generally along the boundary of that area, along the boundary of the Taringamotu Tribal Committee Area hereinbefore described, and along the boundary of the Taumarunui Tribal Committee Area hereinbefore described to the confluence of the Wanganui River and the Ohura River, being the point of commencement.

*Taurewa Tribal Committee Area*

All that area bounded by a line commencing at the north-western corner of Section 5, Block XIII, Kaitieke Survey District, being a point on the boundary of the Kakahi Tribal Committee Area hereinbefore described; thence north-easterly generally along the boundary of that area to a point in the middle of the Wanganui River in line with the north-western boundary of Taurewa East No. 4 Block; thence southerly up the middle of the Wanganui River to its confluence with the Mangatepopo Stream; thence along a right line to Trig. Station Mangatepopo, in Block VII, Tongariro Survey District; thence along a right line to Trig. Station D (Ngauruhoe), a right line to Trig. Station Paretaitonga, a right line to Trig. Station Te Kahatu; thence along a right line to the source of the Makatote Stream; thence down the middle of the said stream to its intersection with the eastern boundary of Section 13, Block VIII, Manganui Survey District; thence southerly along the said eastern boundary and the eastern boundary of Section 18 of the aforesaid block and its production to the middle of the Manganuiateao River; thence down the middle of the said river to a point in line with the south-western boundary of Section 24,

Block XI, Manganui Survey District; thence along that boundary and its production to the middle of the Raetihi-Waimarino Road; thence along the middle of that road to a point in line with the south-western boundary of Section 24, Block VII, Manganui Survey District; thence along that boundary to and along the south-eastern and south-western boundaries of Section 4, Block VI, Manganui Survey District, and the production thereof to the middle of the Makino Road; thence north-easterly along the middle of the said road to a point in line with the south-western boundary of Section 2, Block VI, Manganui Survey District; thence to and along that boundary, along the south-western boundary of Section 1, Block VI, along the south-western and north-western boundaries of Section 4, Block II, along the south-western and north-western boundaries of Section 3, Block I, Manganui Survey District, to its northernmost corner; thence due north along a right line to a point in the middle of the Ruatiti Stream, and northerly up that stream to a point in line with the south-western boundary of Section 8, Block XIII, Kaitieke Survey District; thence north-westerly along the south-western boundary of the said Section 8 and its production to the middle of the Kokako Road; thence south-westerly along the middle of that road to a point in line with the north-eastern boundary of Section 5, Block I, Manganui Survey District; thence to and along that boundary and the north-eastern boundary of Section 4, Block XIII, Kaitieke Survey District, to the north-western corner of Section 5, Block XIII, being the point of commencement.

TUWHARETOA No. 4 TRIBAL DISTRICT

*Korohe Tribal Committee Area*

All that area bounded by a line commencing at Trig. Station 28 (Manukaiaapu), in Block XVI, Kaimanawa Survey District; thence westerly along a right line to Trig. Station F, in Block X, Kaimanawa Survey District, and its production to the middle of the Waiouru-Tokaanu Road; thence northerly along the middle of the said road, to and down the middle of the Waihouoru Stream and the Tongariro River to a point due west of the northernmost corner of Tokaanu No. 3A 1 Block, in Block VI, Puketiki Survey District; thence north-easterly along a right line to the easternmost corner of Block III, Puketiki Survey District; thence south-easterly along the Land District boundary to the eastern shore of Lake Taupo; thence southerly along the said eastern shore to the middle of the Waimarino River; thence up the middle of the said river to a point in line with the eastern boundary of Hautu 1B 2B 5B Block, in Block VI, Waiotaka Survey District; thence southerly along a right line to Trig. Station 27 (Motumatai), in Block XV, Mangamaire Survey District; thence westerly along a right line to Trig. Station 28 (Manukaiaapu), being the point of commencement.

*Tongariro Tribal Committee Area*

All that area bounded by a line commencing at Trig. Station Ruapehu; thence northerly along a right line to Trig. Station (Paretaitonga), a right line to Trig. Station D (Ngauruhoe); thence along a right line in the direction of Trig. Station (Mangatepopo) to a point in line with a right line from the northernmost corner of Okahukura No. 8M 2B 3B Block, passing through Trig. Station A, in Block I, Pihanga Survey District; thence north-easterly along the said right line to the northernmost corner of the aforesaid block; thence along the north-eastern boundary of the aforesaid Okahukura No. 8M 2B 3B Block, and along the western, south-western, and south-eastern boundaries of the Ngapuna Block to Lake Rotoaira; thence along the western, northern, and eastern shore of the said lake to the mouth of a stream approximately 50 chains north-west of the mouth of the Pouu Stream; thence north-easterly along a right line to Trig. Station C (Pihanga), along the south-eastern boundaries of Ohuanga North No. 4 and No. 1B Blocks and the production thereof to the middle of the Tongariro River, being a point on the boundary of the Korohe Tribal Committee Area hereinbefore described; thence in a generally southerly direction along the boundary of the aforesaid area to Trig. Station 28 (Manukaiaapu), in Block XVI, Kaimanawa Survey District; thence south-westerly along a right line to Trig. Station 24 (Te Rotete), a right line to Trig. Station C (Anahitotara); thence westerly along a right line to Trig. Station A (Totem), and a right line to the middle of the Waiouru-Moawhango Road at its junction with the Waiouru Road in Block IX, Moawhango Survey District; thence north-westerly along a right line to Trig. Station Ruapehu, being the point of commencement.

*Turangī Tribal Committee Area*

All that area bounded by a line commencing at the westernmost corner of Waipapa No. 1N Block, in Block III, Pihanga Survey District; thence north-easterly along the north-western boundary of Waipapa No. 1 Block, and its production to the middle of the Turangi-Tokaanu Main Road; thence westerly along the middle of the said road to a point in line with the eastern boundary of Tokaanu B No. 2B 2 Block; thence to and along the eastern and northern boundaries of the said block, and along the south-western boundaries of Tokaanu B Nos. 1G, 1E, 1F, 1D, and 1A Blocks, and the production thereof to a point on a right line from the northernmost corner of Waihi-Kahakaharoa No. 9 Block to the easternmost corner of Block III, Puketiki Survey District; thence north-easterly along this right line to the easternmost corner of the said Block III, being a point on the boundary of the Korohe Tribal Committee Area hereinbefore described; thence in a generally southerly direction along the boundary of the aforesaid area, and along the boundary of the Tongariro Tribal Committee Area hereinbefore described to the southernmost corner of Waipapa No. 2B Block; thence north-easterly along a right line to the westernmost corner of Waipapa No. 1N Block, being the point of commencement.
