Declaring Portion of Railway Land at Tuatapere to be Crown Land

IN pursuance and exercise of the powers and authorities vested in me by the Public Works And 1992 in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act, 1924.

APPROXIMATE area of the piece of land: 1 acre 13 perches. Being part Section 6, Railway Reserve, Block XIII, Waiau Survey District.
