Price Order No. 905 (Cocoa)

PURSUANT to the powers conferred on it by the Control of Prices Act, 1947, the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order:—

1. This Order may be cited as Price Order No. 905, and shall come into force on the 12th day of July, 1948.
2. (1) Price Orders No. 735* and No. 794† are hereby revoked.
(2) The revocation of the said Orders shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.

(2) If in respect of any lot of cocoa sold by a retailer the maximum price calculated in accordance with the foregoing provisions of this clause is not an exact number of pence or halfpence, the maximum price of the lot shall be calculated to the next upward halfbenry. next upward halfpenny.
