1. This Order may be cited as Price Order No. 913, and shall be read together with and deemed part of Price Order No. 889* (hereinafter referred to as the principal Order).

2. This Order shall come into force on the 5th day of August,

3. The principal Order is hereby amended by revoking subclause (3) of clause 7, and substituting the following subclause:—

"(3) On and after the 1st day of August, 1948, every licensee of licensed premises who has 10 oz. containers available, and on and after the 1st day of October, 1948, every licensee of licensed premises shall, unless otherwise required by the customer, serve all beer, except beer served from its original bottle or beer served in a lounge or dining-room in 10 oz. containers and any container in which beer is served shall be filled as nearly as possible to its full
