

Notice of Intention to take Leasehold Estates in Land in Block VIII, Papakaio District, and in Section 74A, Steward Settlement, for an Aerodrome

The Servicemen's Settlement and Land Sales Act, 1943.—Notice declaring Land taken for the Settlement of Discharged Servicemen

WHEREAS, pursuant to section 24 of the Servicemen's Settlement and Land Sales Act, 1943, notice was given of the intention of the Minister of Lands to take under Part II of the said Act the land described in the Schedule hereto, and a copy of the said notice was published in the *New Zealand Gazette* No. 46 on the 21st day of August, 1947, at page 1022:

And whereas an objection was made by the owner in the manner prescribed by the said Act objecting to the taking of the said land: And whereas the Minister of Lands did not revoke his notice of intention to take the said land:

And whereas the owner has withdrawn the objection to the taking of the said land:

And whereas the Land Sales Committee did on the 18th day of December, 1947, make an order determining that the land is suitable for the settlement of a discharged serviceman or of two or more discharged servicemen:

And whereas the said land is not the land of any serviceman who is for the time being serving outside New Zealand in any of His Majesty's Forces or in any British ship:

Now, therefore, the Minister of Lands, acting in pursuance of section 27 of the said Act, doth hereby declare that the land described in the said Schedule is taken for the settlement of discharged servicemen, and hereby specifies the 3rd day of March, 1948, as the date on which the said land shall be deemed to be vested in His Majesty the King.
