## PATEA BOROUGH COUNCIL

## RESOLUTION MAKING SPECIAL RATE

IN pursuance and in exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, and of all other powers (if any) it thereunto enabling, the Patea Borough Council hereby resolves as follows:—

"That, for the purpose of providing for the payment of principal and interest and other charges on the loan of one thousand eight hundred pounds (£1,800), authorized to be raised by the Patea Borough Council under the above-mentioned Act, for the purpose of restoring and extending the borough water-supply system, the Patea Borough Council hereby makes and levies a special rate of one halfpenny ( $\frac{1}{2}$ d.) in the pound on the rateable value (on the basis of the unimproved value) of all rateable property in the Borough of Patea; and that such special rate shall be an annually recurring rate during the currency of such loan and be payable annually on the 1st day of June in each and every year during the currency of such loan, being a period of twenty years or until the loan is fully paid off."
