A PROCLAMATION

BY virtue and in exercise of the powers and authorities conferred upon me by section eighteen of the Forests Act, 1921-22, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby set apart the Crown land described in the Schedule hereto as a permanent State forest.

NELSON LAND DISTRICT.—NELSON CONSERVANCY

ALL that area in the Nelson Land District, Waimea County, containing by admeasurement 862 acres, more or less, and being Section 2, Block II, Motupiko Survey District. As the same is more particularly delineated on plan No. 108/57, deposited in the Head Office of the State Forest Service at Wellington, and thereon bordered red.

PURSUANT to section five of the Maori Purposes Act, 1939, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby revoke a proclamation made on the twenty-ninth day of November, one thousand nine hundred and forty-one, and published in the *Gazette* on the fourth day of December, one thousand nine hundred and forty-one, at page 3840, and affecting Section 9, Block V, Hohoura East Survey District, and other blocks, in so far as it affects the lands described in the Schedule hereto.

Amending an Order in Council apportioning Representation on the Marlborough Electric-power Board

PURSUANT to the Electric-power Boards Act, 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby amend the Order in Council dated the twenty-ninth day of October, one thousand nine hundred and twenty-three, and published in the *Gazette* on the first day of November, one thousand nine hundred and twenty-three, apportioning representation on the Marlborough Electric-power Board by adding to the Schedule thereto the constituent district of Borough of Picton; and, further, doth hereby determine that the said constituent district of the Borough of Picton shall have one representative on the Marlborough Electric-power Board, the total number of members of which is consequently increased to nine; and doth further determine that the first election of the representative of the said constituent district of the Borough of Picton shall be held on Wednesday, the nineteenth day of May, one thousand nine hundred and forty-eight.

Consenting to the Raising of a Loan of £4,000 by the Aka Aka Drainage Board and prescribing the Conditions thereof

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

WHEREAS the Aka Aka Drainage Board (hereinafter called the said local authority), being desirous of raising a loan of four thousand pounds (£4,000), to be known as "Machinery Loan, 1947" (hereinafter called the said loan), for the purpose of acquiring machinery for land drainage, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called the said Act), and it is expedient that the precedent consent of the Governor-General in Council, as required by the said Act, should be given to the raising of the said loan:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of four thousand pounds (£4,000), and in giving such consent doth hereby determine as follows:—

(1) The term for which the said loan or any part thereof may be raised shall not exceed eight (8) years.

(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate or rates exceeding three pounds five shillings (£3 5s.) per centum per annum.

(3) The said loan or any part thereof, together with interest thereon, shall be repaid by equal aggregate annual or half-yearly instalments extending over the term as determined in (1) above.

(4) The payment of such instalments shall be made in New Zealand, and no instalments shall be paid out of loan-moneys.

(5) The rate payable for brokerage, underwriting, and pro-curation fees in respect of the raising of the said loan or any part thereof shall not in the aggregate exceed one-half per centum of any amount raised.

(6) No moneys shall be borrowed under this consent after the expiration of two years from the date hereof.
