HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

WHEREAS the land described in the Schedule hereto has been duly set apart for a site for a public hall: And whereas it is expedient that the control of the said reserve should be vested in the Laingholm Central Improvement Society (Incorporated):

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in exercise of the powers and authorities conferred upon him by section seventeen of the Public Reserves, Domains, and National Parks Act, 1928, doth hereby vest the control of the said reserve in the Laingholm Central Improvement Society (Incorporated), subject to the conditions hereinafter contained, that is to say:—

1. The period for which the control of the reserve is hereby vested shall be five years from the date hereof.

2. The said Society shall prepare a report each year ending on the thirty-first day of March, together with a statement of receipts and expenditure in connection with the said reserve.

A copy of every such report and statement shall be sent to the Minister of Lands as soon as possible after each financial year.
