Commission to Inquire Into and Report on Treatment of Press Representatives—" Kaka" Aircraft Disaster

To all to whom these presents shall come, and to the HONOURABLE SIR HAROLD FEATHERSTON JOHNSTON, K.C.

WHEREAS it has been deemed expedient that a Commission W shall issue to inquire into the circumstances relating to the releasing of information to the public regarding the recovery of the bodies and the finding of the Electra aircraft "Kaka," ZK-AGK, on Mount Ruapehu, and particularly to inquire whether there was any undue or improper withholding of public information or restrictions placed on Press representatives, and if so upon whose dimensione directions :

(2) If so, by whose orders or directions was such information withheld or restrictions imposed?
(3) Whether arising out of the present inquiry it is expedient or practicable to lay down any general principles as to the privileges or freedom or obligations of the Press in similar circumstances. And you are hereby authorized to conduct any inquiry under these presents at such times and places as you deem expedient, with power to adjourn from time to time and place to place as you think fit, and to call before you and to examine on oath or otherwise such persons as you think capable of affording you information as to the matters aforesaid, and to call for and examine all such papers and reports as you deem likely to afford you the fullest information and reports as you deem likely to afford you the fullest information on any such matters :

And, using all due diligence, you are required to report to me not later than the thirty-first day of December, one thousand nine hundred and forty-eight, your finding and opinion on the matter aforesaid together with such recommendations as you think fit to make in respect thereof:

make in respect thereof: And you are hereby strictly charged and directed that you shall not at any time publish or otherwise disclose, save to me in pursuance of these presents or by my direction, the contents or purport of any report so made or to be made by you: And it is hereby declared that this Commission shall continue in full force although the inquiry be not regularly continued by adjournments from time to time or from place to place: And, lastly, it is hereby further declared that these presents are issued under and subject to the provisions of the Commissions of Inquiry Act, 1908.
