"In pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Christchurch City Council hereby resolves as follows:—

"That, for the purpose of providing the interest and other charges on a loan of one hundred and fifty-one thousand pounds (£151,000), authorized to be raised by the Christchurch City Council under the above-mentioned Act, for the purpose of providing waterworks for the purpose of improving the water-supply of the City of Christchurch, the said Christchurch City Council hereby makes and levies a special rate of two hundred and nineteen thousand nine hundred and ninety-nine one million two hundred and fifty thousandths of a penny (\frac{21969000}{125000000}d.) in the pound (£0.00073333) on the rateable value (on the basis of the unimproved value) of all rateable property comprised within the City of Christchurch; such special rate to be an annually recurring rate and to be payable yearly on the 1st day of April in each and every year during the currency of the loan, being a period of thirty (30) years or until the loan is fully paid off."
