And whereas the said local authority proposes, pursuant to the terms of such aforesaid requisition, to raise a loan of eight thousand five hundred pounds (£8,500), to be known as "Sewerage Loan, 1949," for the purpose of purchasing earthenware pipes for use in connection with the provision of such aforesaid works:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section cleven of the Local Government Loans Board Act, 1926, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of eight thousand five hundred pounds (£8,500), and in giving such consent doth hereby determine as follows:—

(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or leaders a rate or rates exceeding three pounds five shillings

(3) The said loan or any part thereof, together with interest thereon, shall be repaid by equal aggregate annual or half-yearly instalments extending over the term as determined in (1) above.

(4) The payment of such instalments shall be made in New Zealand and no instalments shall be paid out of loan-moneys.

(5) The rate payable for brokerage, underwriting, and procuration fees in respect of the raising of the said loan or any part thereof shall not in the aggregate exceed one half per centum of any amount raised. any amount raised.

(6) No moneys shall be borrowed under this consent after the expiration of two years from the date hereof.
