Where the purchase-price of any maize to which this Order applies is payable to the agent effecting the sale on behalf of a grower the agent may deduct from the maximum price payable to the grower in accordance with the foregoing provisions of this Order an amount computed at the rate of 4d. per bushel in respect of his charges.
