(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate or rates exceeding three pounds five shillings

(£3 5s.) per centum per annum.
(3) The said loan or any part thereof shall be repaid by annual instalments of principal of not less than two hundred pounds (£200) each extending over the term as determined in (1) above.

(4) The payment of interest and principal in respect of the said

(5) No amount payable either as interest or as principal in respect of the said loan shall be paid out of loan-money.
(6) The rate payable for brokerage, underwriting, and pro-curation fees in respect of the raising of the said loan or any part thereof shall not in the aggregate exceed one half per centum of any amount raised amount raised.
