#### A PROCLAMATION

DURSUANT to the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the Crown land described in the Schedule hereto is hereby set apart for road; and I do also declare that this Proclamation shall take effect on and after the twenty-ninth day of August, one thousand nine hundred and forty-nine.

### SCHEDULE

APPROXIMATE area of the piece of Crown land set apart: 2 roods 9.3 perches.

Being part Patea River-bed.

Situated in Block VII, Carlyle Survey District (Taranaki R.D.). (S.O. 8243.)
