

*Varying the Determinations in Respect of the Balance (£10,000) of the Dunedin City Council's Loan of £100,000 by Extending the Term Within Which the Said Sum May be Borrowed*

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

WHEREAS by Order in Council made on the ninth day of June, one thousand nine hundred and thirty-nine, and subject to the determinations as to borrowing and repayment therein set out, consent was given to the raising in New Zealand by the Dunedin City Council (hereinafter called the said local authority) of a loan of one hundred thousand pounds (£100,000), to be known as "Public Works Loan, 1938" (hereinafter called the said loan):

And whereas by Order in Council made on the twenty-seventh day of August, one thousand nine hundred and forty-seven, the determinations aforesaid were varied in respect of a portion of the said loan amounting to thirty thousand pounds (£30,000) by extending the period within which such sum of thirty thousand pounds (£30,000) or any portion thereof might be raised to the twenty-seventh day of August, one thousand nine hundred and forty-nine:

And whereas the sum of ten thousand pounds (£10,000) (hereinafter called the said sum) has still not yet been raised, and it is expedient to again vary the determinations aforesaid in respect of the said sum by further extending the period within which the said sum or any portion thereof may be raised:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the Local Government Loans Board Act, 1926, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby vary the determinations aforesaid in respect of the said sum by prescribing that no moneys shall be borrowed under the consent given by the Order in Council made on the ninth day of June, one thousand nine hundred and thirty-nine, after the twenty-seventh day of August, one thousand nine hundred and fifty-one.

*Authorizing the Laying-off of a Street (Brentwood Avenue Extension) in the Borough of Mount Eden*
