

Block VII, Wharekawa Survey District, and intersecting Lots 20, 21, 22, and 23 as shown on the plan numbered 7211 deposited in the office of the District Land Registrar at Auckland, being parts of Wharekawa Nos. 2 and 3 Blocks, to and along the middle of part of Wharekawa No. 1 Block, being the land between Lots 13 and 15, as shown on the plan numbered 31704, deposited as aforesaid, and between Lots 1 and 3, as shown on the plan numbered 27867, deposited as aforesaid, and the said Lot 15, again along the middle of a public road, to and along the western, southern, and eastern boundaries of Allotment 213, Koheroa Parish, to and again along the middle of a public road and the middle of the Pokeno-Miranda Road to a point in line with the western boundary of Allotment 82, Koheroa Parish; thence along a right line, to and along the western and northern boundaries of the said Allotment 82, crossing the said road intersecting the said northern boundary to the Firth of Thames; thence southerly generally along the shores of the said Firth of Thames and the left bank of the Miranda Stream to a point in line with the north-western boundary of Lot 2, as shown on the plan numbered 28111, deposited as aforesaid, being part of Waitakaruru No. 3c 1 Block; thence along a right line across the said Miranda Stream, to and along the north-western boundary of the said Lot 2, a right line across a public road, to and along the north-western boundary of Lot 1, as shown on the said plan numbered 28111, along part of the north-western boundary of Waitakaruru No. 4c 5 Block, the north-western boundary of Waitakaruru No. 4c 3 Block, another part of the north-western boundary of the said No. 4c 5 Block, and the north-western boundaries of Waitakaruru No. 4c 4 Block, and Lot 3, as shown on the plan numbered 21822, deposited as aforesaid, being part of Waitakaruru No. 4 Block, to the western corner of that Lot; thence along a right line, being the production of the last-mentioned boundary, across Sections 8 and 10, Block VIII, Wharekawa Survey District, to and along the north-eastern boundary of Section 1, the north-eastern, eastern, and south-eastern boundaries of Section 2, both sections being of Block VIII aforesaid, and along the northern boundary of Section 5, Block II, Piako Survey District, to its intersection with a right line between Trig. Station No. 135 (Rafarua), and the north-western corner of Section 38, Block VII, Piako Survey District; thence along the said right line, to and along the south-western boundaries of the said Section 38, parts Sections 4 and 5 of the said Block VII, part Section 12 of Block VII aforesaid, and Lot 2 of the said Section 12, along the abutment of a public road, another part of the south-western boundary of the said Section 12, the abutment of another public road, and a further part of the south-western boundary of the said Section 12, and the south-western boundary of Section 5 of Block VII aforesaid, along the western boundaries generally of part Sections 1 and 2, both of Block XV, Piako Survey District, a right line across a public road, to and along the western boundary generally of Section 9 Block XVI, Piako Survey District, to and along the north-western boundaries of Sections 1s and 3s, Tainui Settlement, the north-western and south-western boundaries of Hoe-O-Tainui North No. 6b 2j 1 Block, along the south-western boundaries of Hoe-O-Tainui North No. 5b 2 Block, Sections 6 and 7 of Block VIII, Hapuakohe Survey District, Hoe-O-Tainui North Nos. 5a North 2a 2, 5a North 2a 1, and 5a North 2b Blocks, and Lot 6 as shown on the plan numbered 13199 deposited as aforesaid, being part of Hoe-O-Tainui North No. 5a South 2 Block, Lot 8 as shown on the said plan numbered 13199, being part of Section 1 of Block XII, Hapuakohe Survey District, Hoe-O-Tainui South No. 4a Block, Sections 18, 17, 16, and 15 of Block XII aforesaid, along the south-western boundaries of Hoe-O-Tainui South No. 1a 2 and 1a 1 Blocks, Lots 1 and 2, as shown on the plan numbered 29197 deposited as aforesaid, Lot 1 as shown on the plan numbered 8138 deposited as aforesaid, part of Lot 6 as shown on the plan numbered 11661 deposited as aforesaid, Lots 1 and 2 as shown on the plan numbered 12366, deposited as aforesaid, Lots 1 and 2 as shown on the plan numbered 13235 deposited as aforesaid, Lots 6 and 5 as shown on the plan numbered 12470 deposited as aforesaid, Lot 1 as shown on the plan numbered 29321 deposited as aforesaid, and part of Lot 8 as shown on the plan numbered 2463 deposited as aforesaid, the said lots being parts of Hangawera Block, along the south-western boundaries of Lot 2 as shown on the plan numbered 20628 deposited as aforesaid, part of Lot 1 as shown on the plan numbered 3622 deposited as aforesaid, and Lot 9 as shown on the plan numbered 6948, deposited as aforesaid, the said lots being parts of Motumaoho No. 1 Block, along the south-western boundaries of Lots 1 and 2 as shown on the plan numbered 8165, deposited as aforesaid, being parts of the said Motumaoho No. 1 Block and Kohatupapanui Block, Lot 1 as shown on the plan numbered 7723 deposited as aforesaid, being parts of the said Kohatupapanui Block and Mangaotupua Block, Lot 2 as shown on the plan numbered 26272, deposited as aforesaid, and part of Lot 2 as shown on the plan numbered 7860 deposited as aforesaid, being parts of the said Mangaotupua Block, and crossing intersecting roads and the Auckland-Rotorua Railway; thence south-easterly and north-easterly along the south-western boundaries of Lot 1 and the south-eastern boundaries of Lot 2 as shown on the plan numbered 20705, lodged in the office of the District Land Registrar aforesaid; thence south-easterly along the western boundaries of Lots 5, 4, 3, 2, and 1 as shown on the plan numbered 11745 deposited as aforesaid, being parts of Tahuroa No. 2 Block, and a right line, being the last-mentioned boundary produced to the middle of Scotchman's Valley Road; thence along the middle of that road to a point in line with the south-western boundary of Lot 2 as shown on the plan numbered 15442 deposited as aforesaid, being part of Tahuroa No. 2 Block; thence along a right line, to and along the said south-western boundary of Lot 2, along the south-western boundaries of part KIWITAHU No. 3c Block, part KIWITAHU No. 3b Block as shown on the plan numbered 4138 deposited as aforesaid, and part Te-au-O-Waikato No. 8 Block, to and along the western boundary of KIWITAHU No. 2b Block, the western and south-eastern boundaries of KIWITAHU No. 2d Block, and up the Topehaehae Stream to a point in line with the southern boundary of

KIWITAHU No. 1d 1 Block; thence along a right line, to and along the said southern boundary, and along the western boundaries generally of part of Lot 1, and Lots 2, 4, 5, 6, and 7, as shown on the plan numbered 17890 deposited as aforesaid, being parts of Te Pae-O-Turawaru No. 2c 1 and 2c 2 Blocks to the south-western corner of the last-mentioned lot; thence south-westerly generally along the north-western boundaries of part of Lot 43, as shown on the plan numbered 14557 deposited as aforesaid, Lot J, as shown on the plan numbered 2756 deposited as aforesaid, and Lots 1 and 2, as shown on the plan numbered 22079 deposited as aforesaid, the said lots being parts of Hinuera No. 2 Block; thence along a right line across a public road, to and along the north-western boundaries of Sections E 2 and W 2, Whitehall Settlement, along a right line, being the last-mentioned boundary produced across a public road, to and along the north-western boundary of part of Hinuera No. 2 Block; thence southerly generally along the south-western boundaries of the last-mentioned block, the north-western boundary of Section 15, Karapiro Settlement, the eastern boundary of part of Lot 2 as shown on the plan numbered 3569 deposited as aforesaid, being parts of Allotments 277 and 278 of Hautapu Parish, a right line across French Pass Road, to and along the western boundary generally of Section 9 of the said Karapiro Settlement, and a right line, being the last-mentioned boundary produced to the middle of the Karapiro Stream; thence down the middle of that stream to the eastern boundary of the Borough of Cambridge; thence northerly, westerly, and southerly along the boundary of the Borough of Cambridge as described in *New Zealand Gazette* of 1896, page 985, to the middle of the Waikato River; thence down the middle of the Waikato River to a point in line with the eastern boundary of the City of Hamilton; thence along a right line to and along the eastern and northern boundaries of the City of Hamilton, as hereinbefore described to the middle of the Waikato River; thence again down the middle of the Waikato River to the south-eastern boundary of the Borough of Ngaruawahia; thence along the south-eastern, north-eastern, and northern boundaries of the Borough of Ngaruawahia as described in *New Zealand Gazette* of 1921, page 501, and the production of the last-mentioned boundary to the middle of the Waikato River; thence again down the middle of the Waikato River to the southern boundary of the Borough of Huntly; thence along the southern, eastern, and northern boundaries of the Borough of Huntly as described in *New Zealand Gazette* of 1945, page 1373, to the middle of the Waikato River; thence again generally down the middle of the Waikato River so as to include within the said boundaries all islands in the said river, to the point of commencement.

### THIRD SCHEDULE

#### BOUNDARIES OF THE ROTOTUNA RIDING OF THE COUNTY OF WAIKATO

ALL that area in the South Auckland Land District, situated in the County of Waikato, bounded by a line commencing at a point on the right bank of the Waikato River and in line with the north-western boundary of Section 222, Suburbs of Newcastle North, and running easterly generally along a right line, to and along the boundary of the Ngaruawahia Borough as described in *New Zealand Gazette* No. 18 of the 17th day of February, 1921, page 501, to and along the south-western boundary of Section 200, Suburbs of Newcastle North aforesaid, along a right line across a public road, to and along the south-western and south-eastern boundaries of Section 209, along the south-eastern boundaries of Sections 210, 211, and 212, Suburbs of Newcastle, aforesaid, the abutment of a public road, the south-eastern and eastern boundaries of Allotment 234 to the western corner of Allotment 108, Parish of Komakorau; thence along the northern boundary of Allotment 108, aforesaid, to and along the northern boundary of an area of 18 perches, being land taken for road by Proclamation in the *New Zealand Gazette* No. 44 of the 14th day of August, 1947, page 979, and as shown on the plan numbered 32171, lodged in the office of the Chief Surveyor at Auckland, along the northern and eastern boundaries of an area of 7 acres 3 roods 29 perches, the eastern boundary of an area of 4 acres 2 roods 39 perches, being land taken by Proclamation in the *New Zealand Gazette* No. 44 of the 14th day of August, 1947, page 978, to a point in line with the north-western boundary of Allotment 103; thence along a right line, to and along the north-western and north-eastern boundaries of the aforesaid Allotment 103, to and along the southern and south-eastern boundaries of Lot 2, as shown on plan numbered 9839, deposited in the office of the District Land Registrar at Auckland, and being part of Allotment 215, to and along the southern boundary of Allotment 214, along a right line, being the last-mentioned boundary produced, across a public road to its south-eastern side; thence along the north-western, south-western, and south-eastern boundaries of Lot 4, as shown on plan numbered 6931, deposited as aforesaid, and being part of Allotments 215 and 229, along the south-western side of Rogers Road to a point in line with the south-eastern side of a public road, forming the north-western boundary of Lot 2, as shown on the plan numbered 13637, deposited as aforesaid, and being part of the aforesaid Allotment 229; thence along a right line, to and along the south-eastern side of the aforesaid public road, and along another right line, being that side produced to the eastern side of Kainui Road; thence along the eastern side of the said Kainui Road, to and along the north-western side of the Main Road, to a point in line with the southern boundary of Lot 9, as shown on the plan numbered 3866, deposited as aforesaid, and being part of Allotment 229, aforesaid; thence along a right line, to and along the southern boundary of Lot 9, aforesaid, and along another right line to the north-eastern side of a public road; thence along the north-eastern side of the said public road, to and along the south-eastern boundaries of Lots 7a and 7, as shown on the plan numbered 3787, deposited as aforesaid, and being part of Allotment
