All that area in the South Auckland Land District, situated in the County of Waikato, bounded by a line commencing at a point in Block IV, Komakorau Survey District, being the eastern corner of Lot 3, as shown on the plan numbered 16349, deposited in the office of the District Land Registrar at Auckland, being part of the land granted to the New Zealand Loan and Mercantile Agency Company, Limited, on the 20th day of July, 1876, and running easterly generally along the northern boundary of Lot 10, as shown on the plan numbered 26563, deposited as aforesaid, being part of land granted as aforesaid, to the boundary of the Waikato County; thence southerly generally along the boundary of that county, as hereinbefore described, to and along the south-western boundaries of Tahuroa Nos. 4 and 3 Blocks, to the northern side of Griffins Road; thence south-westerly generally along the northern boundary of the Parish of Tamahere to the south-eastern corner of Lot 6, as shown on plan numbered 9815, deposited as aforesaid, being part of the land granted to the New Zealand Loan and Mercantile Agency Company, Limited, aforesaid; thence along the south-eastern boundary of Lot 6 aforesaid, the south-eastern boundary of Lot 7, as shown on the plan numbered 9815 aforesaid, and along a right line to the angle in Collins Road, being the road angle in the western corner of Lot 10, as shown on plan numbered 7346, deposited as aforesaid, being part of the aforesaid grant, thence along the south-eastern side of Collins Road, along a right line, being that side produced across the Hamilton-Paeroa State Highway to and along the north-eastern and north-western boundaries of part Allotment 13, Parish of Tamahere, and along a right line, being the last-mentioned boundary produced to the middle of the Mangaonua Stream; thence down the middle of that stream to the right bank of the Waikato River; thence northerly generally down the right bank of the Waikato River, aforesaid, to and along the eastern boundary of the City of Hamilton, as hereinbefore described, to and along the south-eastern boundary of the Rototuna Riding, as hereinbefore described, to the point of commencement.

BOUNDARIES OF THE COUNTY OF WAIIPA

ALL that area in the South Auckland Land District, bounded by a line commencing at the southernmost corner of South Suburban Section 109A, Town of Newcastle, where the generally southern boundary of Ngaruawahia Borough meets the right bank of the Waipa River and running in an easterly direction generally along the southern boundary of the Ngaruawahia Borough as described in the *New Zealand Gazette* No. 18 of the 17th day of February, 1921, page 501, to the middle of the Waikato River; thence south-easterly generally up the middle of the Waikato River to its intersection with the generally northern boundary of the City of Hamilton hereinbefore described; thence generally westerly, southerly, and easterly along the boundary of the City of Hamilton aforesaid, to the middle of the Waikato River aforesaid; thence in a south-easterly direction generally up the middle of that river to a point in line with the western boundary of the Leamington Town District as described in the *New Zealand Gazette* No. 56, of the 27th day of July, 1922, page 1853, along a right line, to and along the western, southern, and eastern boundaries of the Leamington Town District, and along a right line, being the last-mentioned boundary produced to the middle of the Waikato River; thence up the middle of the said Waikato River to a point in line with the north-western boundary of the land taken for development of water-power, *New Zealand Gazette* No. 15, of the 20th day of February, 1941, page 306, and being part of Pukekura No. 1 Block; thence southerly generally along a right line, to and along the aforesaid north-western boundary, along a right line across a public road, to and along the north-western boundary of another part of Pukekura No. 1, along the north-western boundary of Section 1, Block XIV, Cambridge Survey District, the north-western boundary of another part of Pukekura No. 1, the north-western boundaries of Pukekura Nos. 2, 3, 4, 5, Section 1, and 6 Blocks, along the south-western boundary of Pukekura No. 7 Block, the north-western boundary of Pukekura No. 8A Block, the north-western and south-western boundaries of Pukekura No. 9 Block, and along the south-western boundaries of Pukekura Nos. 10, 11, 12, part 13 and part 14 Blocks, to the southern corner of the last-mentioned block; thence along a right line to Trig. Station 1427 (Maungatautari), in Block VII, Maungatautari Survey District; thence along a right line running direct for Trig. Station 807 (Uaura), in Block VII, Ngautuku Survey District, to its intersection by the middle of the Waikato River; thence up the middle of the Waikato River aforesaid and Arapuni Lake to a point in line with the northern boundary of Section 10, Block IV, Wharepapa Survey District; thence south-westerly generally along a right line, to and along the northern boundary of Section 10 aforesaid, along another right line, to and along the south-eastern boundary of Section 11, Block III, Wharepapa Survey District, a right line across a public road, to and along the south-eastern boundary of Section 1, Block III aforesaid, the south-eastern boundary of Section 15, Block II, Wharepapa Survey District, along a right line across a public road, to and along the south-eastern boundaries of part Section 3 and Section 45, the abutment of a public road, the south-eastern boundary of Section 46, the aforesaid sections being of Block II aforesaid; thence north-westerly generally along the south-western boundaries of Sections 46, 44, 49, 53, 40, 7, and part Section 4, the aforesaid sections being of the aforesaid Block II, along the south-western boundary of part of Lot 1 as shown on the plan numbered 20102, deposited in the office of the District Land Registrar at Auckland, being part of Wharepunga No. 14B Block and the last-mentioned boundary produced to the middle of the Puniu River; thence down the middle of the aforesaid river to its confluence with the Moerika Stream; thence along a right line, to and along the southern boundary of Lot 2, as shown on the plan numbered 24431, deposited as aforesaid being part of Tokanui A Block, to and along the eastern side of the Great South Road to a point in line with the northern boundary of Lot 1, as shown on the plan numbered 34009, deposited as aforesaid, being part of Tokanui C, No. 4 Block; thence along a right line across the Great South Road aforesaid, to and along the northern boundary of Lot 1 aforesaid to the north-western corner of that lot; thence along a right line across Lot 1, as shown on the plan numbered 4924, deposited as aforesaid, being part of Tokanui C No. 4 Block aforesaid, to the northern corner of Tokanui No. C 11 Block, being a point on the south-eastern boundary of Tokanui No. C 2B Block; thence along the south-eastern and south-western boundaries of the aforesaid Tokanui No. C 2B Block, the south-western boundary of part Section 3, Block X, Puniu Survey District, to and along the southern boundary of Lot 2, as shown on the plan numbered 27311, deposited as aforesaid, being part of Ouruwhero Nos. 3U 1 and 3U 2 Blocks, the southern boundary of part Ouruwhero No. 3U 2 Block, along the eastern boundary of part Section 1, Block X, Puniu Survey District, aforesaid, the eastern end and the southern side of a public road, the southern boundary of another part of the aforesaid Section 1, and along a right line, being the last-mentioned boundary produced to the western side of the North Island Main Trunk Railway; thence along the western side of that railway, to and along the southern boundary of another part of Section 1 aforesaid, to and along the southern and western boundaries of another part of the aforesaid Section 1, as shown on plan numbered 22692, deposited as aforesaid, to and along the southern boundary of Lot 3, as shown on the plan numbered 13852, deposited as aforesaid, being part of Kakepuku Nos. 11C 2F 2 and 12 Blocks, along the southern boundaries of Sections 6 and 5, and part of Section 4 of Block IX, Puniu Survey District, along the southern boundary of Lot 1 as shown on the plan numbered 15110, deposited as aforesaid, being part of the aforesaid Section 4, along a right line through Sections 11 and 10, Block IX, aforesaid, to the western corner of a former Section 3 of the said Block IX; thence along another right line passing through the aforesaid Section 10 and through
