A PROCLAMATION

PURSUANT to the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the First Schedule hereto is hereby taken for a gravel-pit; and I do also hereby proclaim and declare that an easement is hereby taken over the land described in the Second Schedule hereto vesting in His Majesty the King full and free liberty, right, licence, and authority in perpetuity to construct and use a right-of-way, with the right for His Majesty's servants, agents, and workmen from time to time and at all times hereafter to go, pass, and re-pass, with or without horses or other animals or vehicles, over the said land, and to maintain, repair, and keep open the said right-of-way for the purpose of providing access to the said gravel-pit, such right-of-way to be appurtenant to the land described in the First Schedule hereto; and I do also declare that this Proclamation shall take effect on and after the thirty-first day of October, one thousand nine hundred and forty-nine.
