ORDER IN COUNCIL

At the Government Buildings at Wellington, this 15th day of March, 1950

## Present: THE HON. K. J. HOLYOAKE PRESIDING IN COUNCIL

W HEREAS, at the request of certain ratepayers in the County of Manukau, the Local Government Commission, in pur-suance of the provisions of the Local Government Commission Act, 1946, resolved to hold a public inquiry into proposals for an altera-tion of the boundaries of the Borough of Papatoetoe and the County of Manukau. of Manukau :

And whereas, in pursuance of the provisions of the said Act, the Local Government Commission has approved as final a scheme bearing date the twenty-seventh day of February, one thousand nine hundred and fifty, providing for the exclusion of the areas described in the First and Second Schedules to the said scheme from the County of Manukau and for the inclusion of such areas in the Borough of Papatoetoe and providing also for the exclusion of the areas described in the Third Schedule to the said scheme from the Borough of Papatoetoe and for the inclusion of such areas in the County of Manukau :

And whereas it is deemed expedient to give effect to the final

scheme as hereinafter appearing: Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the Local Government Commission authorities vested in him by the Local Government Commission Act, 1946, and of all other powers and authorities enabling him in that behalf, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby declare that as on and from the first day of April, one thousand nine hundred and fifty, the areas described in the First Schedule hereto shall be excluded from the County of Manukau and included in the Borough of Papatoetoe; that as on and from the date afore-said the areas described in the Second Schedule hereto shall be excluded from the Borough of Papatoetoe and included in the County of Manukau: and, with the like advice and consent. doth excluded from the borough of Fapatoetoe and included in the County of Manukau; and, with the like advice and consent, doth hereby also declare that the alteration of boundaries of the said county and the said borough hereinbefore made shall be deemed to have been effected under the Municipal Corporations Act, 1933.

#### FIRST SCHEDULE

# Areas Excluded from the County of Manukau and Included in the Borough of Papatoetoe
