NOTICE OF INTENTION TO TAKE LAND

In the matter of the Public Works Act, 1928

PUBLIC notice is hereby given that the Waikato County Council proposes to execute certain public works—to wit, the formation of roads—for which purpose the lands described in the Schedule hereto require to be taken by the Waikato County Council under the provisions of the Public Works Act, 1928, sections 22 and 23. RESOLUTION MAKING SPECIAL RATE

Worker's Dwelling Loan, 1950

IN pursuance and in exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Hobson County Council hereby resolves as follows:—

“That, for the purpose of providing the interest and other charges on a loan of £1,200, authorized to be raised by the Hobson County Council under the above-mentioned Act, for the purpose of refunding to the County Fund Account of the Hobson County Council moneys applied by the Council in the purchase and repair of a dwellinghouse for one of the Council's employees, the said Hobson County Council hereby makes and levies a special rate of one twenty-sixth pence ($\frac{1}{24}$ d.) in the pound (£) upon the rateable value on the basis of the unimproved value of all rateable property in the County of Hobson, and that such special rate shall be an annual-recurring rate during the currency of such loan, being a period of fifteen (15) years or until the loan is fully paid off.”
