NOTICE OF INTENTION TO TAKE LAND

In the matter of the Harbours Act, 1923, the Public Works Act, 1928, and the Acts amending the same.

NOTICE is hereby given that the Lyttelton Harbour Board, a body corporate under the Harbours Act, 1923, proposes to take, under the provisions of the Harbours Act, 1923, and the Public Works Act, 1928, for the purposes of the erection thereon (*inter alia*) of a waterfront industry building—
