Crown Land Set Apart for the Development of Water-power (Lake Taupo and the Waikato River Power Scheme) in Block XIV, Cambridge Survey District

B. C. FREYBERG, Governor-General A PROCLAMATION

PURSUANT to the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the Crown land described in the Schedule hereto is hereby set apart for the development of water-power (Lake Taupo and the Waikato River Power Scheme), and I do also declare that this Proclamation shall take effect on and after the 26th day of June.
