

WELLINGTON CITY COUNCIL
RESOLUTION MAKING SPECIAL RATE

The Wellington City Cemetery (Karori) Improvement Loan, 1950, of £37,000

THE following resolution was duly passed at a meeting of the Wellington City Council held on the 3rd day of July, 1950:—

In pursuance and in exercise of the powers and authorities vested in it in that behalf by the Local Bodies' Loans Act, 1926, and its Amendments, the Wellington City Council hereby resolves as follows:—

"That for the purpose of providing the interest, sinking fund, and other charges on a loan of thirty-seven thousand pounds (£37,000) to be known as the Wellington City Cemetery (Karori) Improvement Loan, 1950, authorized to be raised by the Wellington City Council under the above-mentioned Act, for the purposes of carrying out improvements to paths and erecting a chapel at Karori Cemetery, the Wellington City Council hereby makes and levies a special rate of twenty-one eight-hundredths of a penny ($\frac{21}{800}$ d.) in the pound upon the rateable value (on the basis of the unimproved value) of all rateable property within the whole of the City of Wellington and that such special rate shall be an annual-recurring rate during the currency of such loan and shall be payable yearly on the first day of April in each and every year during the currency of such loan, being a period of twenty-five years, from the fifteenth day of November, 1950, or until the loan is fully paid off."

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Otautau Town Board hereby resolves as follows:—

"That, for the purpose of providing the interest and other charges on a loan of £4,200, authorized to be raised by the Otautau Town Board under the above-mentioned Act, for improvements to the Coronation Hall, the said Otautau Town Board hereby makes and levies a special rate of three farthings of a penny in the pound upon the rateable value of all rateable property of the Otautau Town District, and that such special rate shall be an annual recurring rate during the currency of such loan, and be payable yearly on the 1st day of September in each and every year during the currency of such loan, being a period of twenty years, or until the loan is fully paid off."
