WHEREAS the road described in the Schedule hereto travers Maori land and has been used by the public as a public road :

And whereas the Maori Land Court, by an order made on the 11th day of April, 1949, and issued pursuant to section 484 of the Maori Land Act, 1931, ordered and declared the said road to be

And whereas the said Court is of the opinion that it is in the public interest that the said road should be proclaimed as a public road, and a notification to that effect has been forwarded to the Minister of Lands in terms of section 486 of the Maori Land

Crown Land Set Apart for the Purposes of the Maori Housing Act, 1935

IN pursuance of the power and authority conferred upon me by section 2 of the Maori Housing Amendment Act, 1938, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area of Crown land described in the Schedule harts while he and the generic hereby got court for the purses hereto shall be and the same is hereby set apart for the purposes of the Maori Housing Act, 1935.
